- Congressional Visits took place. Topic of discussion was the Quality Improvement Fund & focus on environments, safety & infrastructure building.
- National Dialogue Topics/Trainings:
 - Workforce: difficulty in finding staff. Currently 5.8 million jobs available in the U.S. with a 62% labor participation rate. It's a competitive choice environment. Programs need to look at marketing to potential employees about purpose & flexibility options.
 - Relationship in Child Welfare: working on getting some powerful research on correlations with Head Start to the Directors.
 - Opioid Addiction: providing supports from Head Start programs to families.
 - Overarching Theme: When Head Start is involved things get better.

- Children under 12 months of age being expelled for behavior
- AZ STEPS Program
 - o Is for Caregivers of 0-12 year olds
- A Bill is currently in the State House to stop expulsions from happening in the State would impact everyone not just DES Child Care
- Children are not expelled when the family & staff have a working relationship together may not always be an appropriate setting, but not expulsion
- Promoting Self Care we can't take it all in so this is vital to staff

- Long Range Goals:
 - o Az. Early Education Expulsion Study (Preliminary Brief)
 - Focus on most current information & data at that time
 - Identifying gaps that may be in existence
 - Raising up promising practices
 - Will be focusing in on HS/EHS programs in the near future

- Has met with Joey Taylor from ADE to how we can increase our work together with children & families
 in the foster care system Joey in attendance today at AHSA.
- o ADE working with FTF in Early Intervention Training Work
- Kindergarten Developmental Inventory (KDI)
 - o 2477 children will be utilizing the KDI.
 - Original projections were only 500 children
- Updates:
 - PDG received 1.3 million dollars in this supplemental grant. Will be using the monies to support infrastructure building.
 - Continued data integration with ReadOn Az & report development
 - Professional Development opportunities for Teachers, Community Trainers, Coaching & T/TA
 Roles
 - Secure 3 contractors for:
 - PDG Evaluation Project
 - KDI Project
 - OnSite coaching & support
 - Access to the MapLit Software how will programs be able to access to that?
 - Developers will be making that data available to everyone.
 - The analysis will be taken further and is still being worked on with details & planning with the developer. AHSA will be kept up-to-date on the progress.
 - Pyramid Models:
 - Working on 3 models
 - 1st model is complete
 - Will be launched at a Social Emotional Conference being launched in the Fall
 - STAR Professional Development being conducted regionally
 - 1 or 2 day options available

CLASS Inquiry:

Patricia Valenzuela – Project Manager Arizona Department of Education (ADE)

- Utilizing CLASS observations from Head Start classrooms
- Currently working with Erin Lyons (CPC) & Mindy Zapata (SWHD) & other people at SWHD
- O How can we work together to match-up and gain efficiencies?
- A Survey Monkey will be sent out to Head Start programs on how CLASS observations are conducted in HS programs.
 - Use of data
 - Observer reliability
- Quality First Redesign
 - o Currently recruiting 80 participants currently has 74 programs that have committed
 - Still looking for 4 home site programs in the designated counties to potentially participate
 - Working on baseline assessments with 40 assessments currently remaining sites will be conducted shortly.
 - Will be trying out a new system that is similar to Performance Standards to use as a framework for high quality early childhood development.
 - Currently being built at the statewide level
 - Will the Quality Rating be assigned in the QRIS system for programs participating in the Redesign process? – Yes – the system is different from the current process and programs have the opportunity to decide when they are ready to be assessed.
