| VII. Coachingwhat progress are programs making since the Leadership Academy? What is working and what is not? | Beth-so much is going on and have new curriculum and the roll out for next year will be very different. Universal coaching, everyone will have a coach. Marlene, from the data driven training. We did individual data analysis for each child. We compared 1 and 2 and teacher has to identify research practices. What supports the activity? Lowest is language/literacy, and math. We discuss in small groups. She has used different strategies according to teachers openness to the changes. Working with staff to use all the resources available to them. Videotaping teachers and mentors to help mentors see themselves. Crisis Nursery has hired a new coach and is working to figure out the process and forms that will be used moving forward. Mentoring mentors-is anyone implementing this. Beth-we are working on the coaching academy. How are messages being given to teachers from all the different voices that they hear (MH, Dis, Managers, Coaches) etc. Requested for this group to share their forms and procedures. Suites break CLASS down into smaller, easier to understand segments. City of Phoenix is piloting TLC.
